All Options Account funds are refundable at any time. All cancellations must be received in writing. Complete Release Waiver of Claim and Assumption of Risk

In consideration of permission granted now or in the future by the Green Bay bible Camp Society (the 'Society') to use the Society's facilities in the Province of British Columbia, I, the undersigned, release the Society and its employees, representatives, volunteers, directors and officers (collectively called 'Green Bay') from all liability and waive as against Green Bay all recourse, loss or damage, including any consequential damage or loss, claims, causes of action of any kind whatsoever that I may suffer or that my next of kin may suffer as a result of participation in the activities (the "Activities") carried out on and in the vicinity of the Society's property (the 'Campgrounds') including the waterfront and dock adjacent to the Campgrounds (the 'Waterfront'), and off-site activities. I voluntarily accept the physical risk together with the legal risk, thereby expressly giving up any right of legal action. I further acknowledge and agree:

To follow the rules and regulations established by Green Bay Bible Camp.

That lifeguards employed by the Society are on duty at the Waterfront only during designated hours and that I assume a greater degree of risk by using the Waterfront outside of the designated hours.

That some of the aforesaid risks and hazards are foreseeable but others are not.

That I nevertheless freely and voluntarily assume all the aforesaid risks and hazards and that, accordingly, my use of the Campgrounds and Waterfront facilities while participating in any Activities shall be entirely at my own risk.

That I have carefully read this COMPLETE RELEASE, WAIVER OF CLAIM AND ASSUMPTION OF RISK and that I fully understand same and that I am freely and voluntarily executing the same.

That I understand that Green Bay does not and will not permit me to participate in 2010 Kids Camp(s) unless I sign the COMPLETE RELEASE, WAIVER OF CLAIM AND ASSUMPTION OF RISK which applies to all of the Activities and that the terms of this Agreement need not be brought to my attention each time I am participating in Activities in order to be effective.

That I give Green Bay the right to use photographs and videos of me involved in Activities for promotional purposes.

Refunds of camp fees are not made for any campers unable to attend, or departing early from the camp for any reason, including health.

We understand that upon completion of camp we are responsible to pick up our child or make appropriate alternate arrangements. Conditions of custody, if applicable, will be fully communicated in writing to camp, including photocopy of the section of any order referring to visitation rights.

Failure to disclose medical problems or concerns at time of registration could result in dismissal.

That I verify that I am 19 years of age or older. (Parent or legal guardian must sign for minor).

That this COMPLETE RELEASE, WAIVER OF CLAIM AND ASSUMPTION OF RISK is binding on myself, my heirs, my executors, administrators, personal representatives, and assigns.

The activity account breakdown here is to help you determine the appropriate amount of \$ for your child to have at camp. Lessons/Training offered at additional cost:

Waterfront Lessons—\$109 (plus applicable taxes):

Participants receive water-ski or wakeboard instruction, plus one recreational pull of their choice each afternoon.

Soccer Skills—\$57 (plus applicable taxes):

Participants will receive instruction in all areas of soccer including ball handling, and shooting. Instruction by certified coaches.
